Dwyka Resources Limited ('Dwyka' or the 'Company')

Exercise of Employee Options

The Directors of the Company announce that the following ordinary shares ('Shares') have today been issued and allotted to certain South African personnel as a consequence of the exercise of options held by those personnel:

- 1,000,000 Shares at a price of A\$1.00 per Share, pursuant to the exercise of options by personnel under the terms of the Company's employee Option Plan; and
- 825,000 Shares at a price of A\$0.52 per Share, pursuant to the exercise by personnel of options granted to them on 17 March 2007.

The exercise of these options increases the Company's cash balances by A\$1,429,000.

Application has now been made to the AIM market of the London Stock Exchange ('AIM') for 1,825,000 Shares to be admitted to trading on AIM ('Admission'). Admission is expected to occur at 8.00am on 25 September 2007.

Following completion of the previously-announced transaction between the Company and KimCor Diamonds Plc ('KimCor'), these personnel will become key employees in the enlarged KimCor. It is intended that, following such completion, the Shares will be sold and proceeds reinvested in KimCor shares.

Following this issue, Dwyka now has 130,494,206 Shares in issue.
